# TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT) (ENGLAND) ORDER 2015 (AS AMENDED)

## NOTICE OF DIRECTION MADE UNDER ARTICLE 4 (1)

THE LONDON BOROUGH OF LEWISHAM ("The Council") HEREBY GIVES NOTICE that the Council being the appropriate Local Planning Authority has made a direction pursuant to Article 4 (1) of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) ("The Order").

This notice refers to the direction which affects land (the remainder of the borough in addition to the existing 2020 Article 4 Direction covering Lewisham's southern wards). The effect of the direction is that development as set in in the schedule to this shall not be carried out on the Land unless planning permission has been granted on an application made under part III of Town and Country Planning Act 1990 (as amended).

The Direction is made under Article (1) of the General Permitted Development Order and in accordance with Schedule of that Order, and will come into force on the 12 months after the direction is made.

### **SCHEDULE**

Development consisting of a change of use of a building and any land within its curtilage from a use falling within (C3) (Dwellinghouses) of the Schedule to the Town and Country Planning (Use Classes) order 1987 (as amended) to a use within Class C4 (Houses in multiple occupation of that Schedule, being development within Class L(b) of part 3 Schedule 2 to the GDPO and not being development comprised with any other Class.

A copy of the Article 4 Direction, map defining the area and associated documents can be seen at Forest Hill Library, Deptford Library, Downham Library and Grove Park Library, during the 6 week representation period. 
